Waste Stream Segregation

BD Disposal Solutions offers collectors to meet the disposal needs of the four categories of waste generated in medical settings. There are two main categories of waste: regulated medical waste and hazardous waste. Regulated medical waste includes Sharps / Infectious Waste, Pharmaceutical (non-hazardous) and Chemotherapy waste. The hazardous waste category is for the collection of RCRA (Resource Conservation and Recovery Act by the U.S. EPA) waste.

This table indicates general guidelines for proper waste stream segregation.





RCRA Hazardous Waste Collectors — DOT

BD RCRA Collectors are intended for Resource Conservation and Recovery Act (RCRA) solid hazardous waste and trace liquids associated with these wastes (see Waste Stream Segregation on page 4).

BD offers two versions of RCRA collectors, **DOT PGII / UN-rated** and **non-DOT**, to meet a variety of needs. DOT / UN-rated RCRA collectors are designed to be transported without being overpacked by the waste haulers. As most waste haulers will overpack smaller collectors whether they are DOT rated or not, BD offers these in 13 and 16 gallon sizes.

What is UN?

The UN or *United Nations Recommendations for the Transport of Dangerous Goods Model Regulations* are suggested regulations for controlling the transport of hazardous materials, including medical waste. The regulations define Packing Groups and test requirements to qualify for a UN-compliant package marking.

A UN-compliant package must have a marking that describes its maximum content weight and the Packing Group that it passed.

It looks like:



4H2 / Y26.9 / S / 09 USA / +CC5871

The regulations describe packaging, labeling and documentation required for transporting hazardous materials, contain a table with codes for each specific type of hazardous material and have several codes for pharmaceutical waste.

What is DOT?

The DOT, or *U.S. Department of Transportation Regulations*, is a government agency regulating fast, safe and efficient transportation of dangerous goods.

What is PGII?

PG (Packing Group) is a Department of Transportation term that groups hazardous materials according to the danger presented by the materials. There are three packing group classifications.


