Do not use for lumbar puncture or in contact with the meninges. Do not use on open wounds or as a general skin cleanser.

Storage: Keep away from fire or flame. Store between 68° to 77° F (20 to 25° C). Avoid freezing and excessive heat above 104° F (40° C). Keep out of reach of children.

Packet: Do not reuse empty packet. Place empty packet in trash collection.
