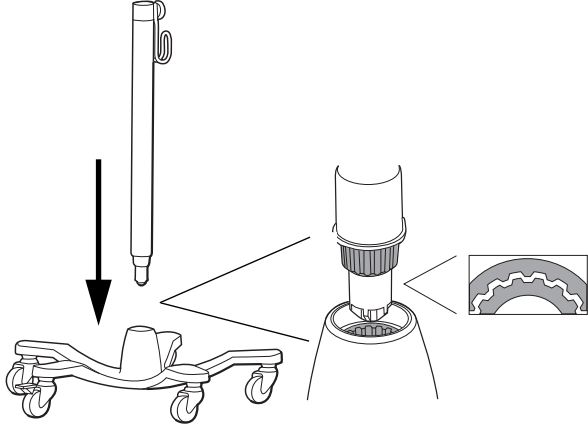
### Table/wall mount



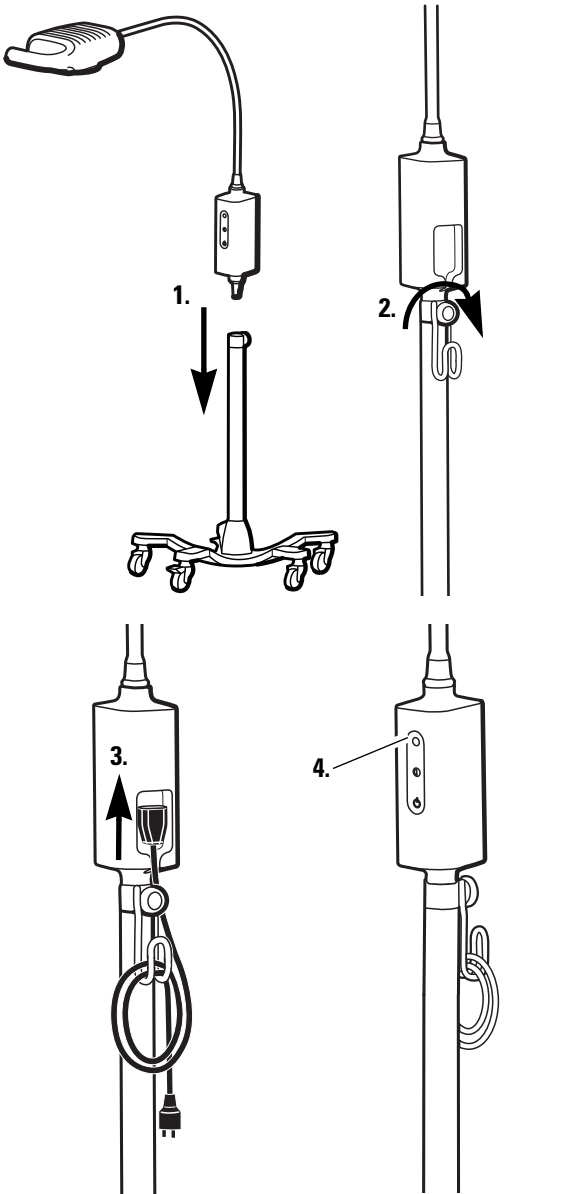





Clean with a damp cloth using warm water and mild detergent or one of the following solutions:

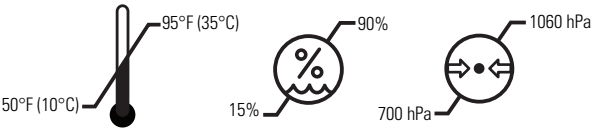

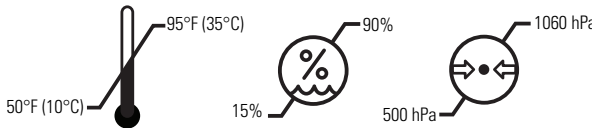
